The European Commission's tabled proposal for a 28<sup>th</sup> company law regime aims to create a uniform legal framework for companies, especially start-ups, operating across Member States. Presented as a tool for reducing administrative burdens and fostering cross-border business, the initiative raises important questions about its implications for workers' rights as well as democratic governance within companies.

From a **trade union perspective**, the proposal could risk undermining existing national safeguards on employee participation. It may also intensify regulatory competition between Member States rather than strengthening social and labour standards across Europe.

Dr. Sebastian Sick, company law expert and member of the German Corporate Governance Kodex Commission, will assess the current ideas and will contextualize these. We will as well discuss the benefits of workers' participation as well as the ongoing practice of circumvention of democratic rights of employees.

This breakfast discussion is meant to bring together different perspectives on European corporate governance initiatives and critically assess the 28<sup>th</sup> regime's potential effects on social Europe.
