Sustainability reporting is currently the talk of the town. It is portrayed as a bureaucratic monster and even blamed for the lack of innovative capacity in European companies. At the moment, the Omnibus initiative is being discussed at the European level—an initiative that aims to dilute numerous obligations for companies to disclose sustainability information as well as to take human rights in the supply chain into account, even before these rules become mandatory. But is reporting really nothing more than a bureaucratic burden? What can the new sustainability reporting actually achieve? What is it good for?

This is what we want to discuss on June 18 together with Odysseus D. Chatzidis, as Chairman of Telekom's European Works Council who is a member of Telekom's Supervisory Board as well. We are delighted to welcome an expert who will share practical insights on how companies can use reporting to position themselves sustainably and ensure long-term viability. Together, we want to explore the role that European Works Councils play in sustainability reporting and the opportunities that arise for employee representation.
